## REGULATION

The cultural association Mitreo Film Festival, for the 24th edition of the festival of the same name, is announcing a selection call for international short films of a maximum duration of 20 minutes (including titles).

The announcement is intended for authors who are 35 years old at 11.59pm on 15 October 2024.

The short films must be strictly 20 minutes long (including titles) and subtitled in Italian/English if in a different language.

Registration takes place exclusively on the FilmFreeWay platform, works via email or shipments will not be accepted.

Candidates must also send the following documents to the festival secretariat's email [infoline@mitreofilmfestival.it](mailto:infoline@mitreofilmfestival.it) by 11.59pm on 15 October, under penalty of exclusion:

- 1) application for participation and attached release, attached to these regulations, complete with the candidate's personal data, drawn up in .pdf format and signed on each page;
- 2) author's biofilmography;
- 3) signed copy of an appropriately scanned identity document (.pdf file format);
- 4) link to the proposed short film and technical sheet;
- 5) synopsis and director's notes of the proposed short film;
- 6) copy of this regulation signed on each page.

Synopsis and director's notes of the work must also be inserted on the FilmFreeWay platform under penalty of exclusion from the selections.

Among all the works registered on the FilmFreeWay platform, meeting the requirements and having sent

the required documents by the deadline of the announcement, the MitreoFilmFestival2024 staff will select, at its sole discretion, 10 short films.

The selections will be made by the MitreoFilmFestival2024 Staff and the judgment is unquestionable.

The selected authors undertake to send a high quality copy of the short film by November 15th. High quality files on USB stick and Blu-ray will be accepted.

### BEST SHORT FILM AWARD 2024

There are three juries for the 24th edition of the MitreoFilmFestival

Technical Jury - composed of cinema experts and representatives of the entertainment world, who will be joined by the President Giuseppe Memeo of the Fernando di Leo Short Film Festival to decree the BEST SHORT FILM PRIZE 2024

The Technical Jury may also assign, at its discretion, one or more special mentions.

The winner, chosen by the technical jury, will be notified in advance and hosted by the festival on the occasion of the final evening. However, he will still be responsible for the costs of the transfer.

Public Jury, represented by the Artzone Association which will award the Public Prize;

Young Jury, made up of students participating in the MitreoFRISKFilmFestival which will reward the short film that best tells the story with innovation and experimentation.

All winners undertake to mention the Award received and the MitreoFilmFestival 2024 in the titles of their short film.

The awards ceremony will take place during the final evening at the Garibaldi Theater, on 14 December.

For anything not indicated in this announcement, the direction of the festival will decide. The call for tenders is officially open from 11.59pm on 16th July. and expires at 11.59pm on October 15th
